4. Number of vacancies : Scheduled Tribe (ST) – 10 (Ten)

The above vacancies are now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for Scheduled Tribe (ST) community as unfilled due to paucity of candidates during the currency of the Ranked List published on 28.03.2008 (Cat.No.314/07 Gazette Date: 28.9.07) for the post.

This is the second NCA Notification in respect of the Scheduled Tribe community and the same is issued due to non availability of sufficient number of qualified applicants in response to first NCA Notification as per Category Number 175/2010 (Gazette Date: 15.06.2010)

Note:- Those who are appointed in the post should serve for four (4) years during the first ten years of their service (including the period of training) anywhere in India or any other Foreign country under defence service or services connected with defence, if required. Those who have completed 45 years of age are exempted from the above Compulsory Military Service.

- 5. **Method of appointment**: Direct Recruitment (from among candidates belongs to Scheduled Tribe (ST) community only.)
- **Note:- 1.** In the absence of ST Candidates, the application of SC candidates will also be considered.
 - **2.** Applications submitted by candidates belonging to other than the communities mentioned above will be rejected. No rejection memo will be issued to them individually.
- 6. **Age**: 18-46**; ie,** only candidates born between 2.1.1965 and 1.1.1993 (both dates included) are eligible to apply for the post. (with usual relaxation in Para 2(i) of the General Conditions)

(For conditions regarding the other age relaxations please see Para 2 of the General Conditions, except Para 2 (i)

7. Qualifications: -

- 1. Degree in Modern Medicine or equivalent qualification.
- 2. Permanent Registration in class A of Modern Medicine with Travancore-Cochin Medical Council.
- **Note**: 1. Persons who have registered themselves with other State/Central Medical Council may also apply, but they will have to get themselves registered under Travancore-Cochin Medical Practitioner's Act before they join duty.
 - 2. For persons who were in defence service, the first one-year of their service will be treated as House Surgency.
 - 3. Personnel working in various departments of Government and acquired MBBS qualification while in service will be given exemption from upper age limit to the extent necessary for Direct Recruitment. The maximum age limit shall in no case exceed 50 years.

The photographs uploaded shall be that taken with in six months and the name of the candidate and date of taking photo should be printed at the bottom of the photo.
